Chaplain's Message June2022

Obeying the Red Hand... or Not

There is an intersection near my home, through which I regularly drive, and often cross on foot. It has a complete set of traffic lights, including a full system of pedestrian lights: "walk;" a count-down to the "don't walk" light (the illuminated red hand); and even audio beeps to inform visually impaired pedestrians which direction they're allowed to cross.

Almost every day, I see pedestrians who pay no attention to these signals. They look both ways, and cross, ignoring the red hand. Even the occasional cyclist will pedal vigorously across, "against the red," when there are no oncoming vehicles.

For my part, I obey the pedestrian signals. And, I sometimes feel uncomfortable, standing there, with no cars coming, obediently waiting for the "walk" signal, while one or more people breeze by me, crossing, with the red hand clearly indicating that they are to stop, and wait, like me. Uncomfortable? Sometimes I feel downright angry!

Am I being too prudish? Or am I just being a good citizen, obeying the rules?

I often think of my friend, now deceased, who was a Roman Catholic priest, and who once described to me his view of the difference between Anglicans and Roman Catholics, linking the two denominations to the cultures of England and Italy – arguably their "home" countries. "In England," he said, "if a motorist comes up to a red traffic light in the middle of the night, with no other vehicles to be seen in any direction, he stops, and waits for the light to turn green. By contrast. an Italian motorist in the same situation – after carefully making sure there is nothing coming – will disregard the red light and drive through. The English, and the Anglicans, will not make a rule unless they intend everyone, under all circumstances, to keep it. But, in Italy, and in Roman Catholicism, there may be a rule, but in a circumstance where that rule is not helpful, it can be dispensed with. You've heard about 'Papal dispensation,' haven't you?"

My friend's words have stuck with me, ever since, and I am frequently reminded of them at that intersection. Is my discomfort and anger at people who defy the "red hand" signal, merely due to my British heritage? Are such folks just coming from a culture where rules can be dispensed with? Sure, these individuals may not be specifically Italian; perhaps they are simply influenced by the growing North American culture of distrust of authority. But, I suggest that it is a cultural thing, not simply individual choice — a cultural environment in which dispensing with a rule is considered acceptable.

Speaking of culture and traffic, my daughter, who is a Flight Attendant, was recently assigned to an aircraft that flew to and from Delhi, India. She has worked that route a couple of times, and has often heard about a shop in Delhi that sells some uniquely beautiful fabric. So, during her recent layover, she caught a "Tuk Tuk" – an enclosed three-wheel motor scooter that looks like a miniature bus – and asked the driver to take her to the address of that shop. On the journey, there was so much traffic, with cars, bikes, Tuk-Tuks and pedestrians all in motion, and with very few traffic lights, that the experience was unnerving, even frightening. Nonetheless, she was delivered to the shop, and back to her hotel with her treasures, without incident.

People who live in Delhi are used to it. They travel those streets regularly and know what is dangerous and what is safe. But could I drive a vehicle there? It is almost certain that I could not do it well, or safely.

My third and last anecdote involves a visit to a computer and cellphone store. One of the technicians, a young woman who was born in India, stood beside me, as we both waited for some data to be transferred into my device. We chatted, and at one point, I asked her to tell me her name. She cheerfully replied with a word that I could not, for the life of me, decipher. "Could you spell that for me, please?" I asked. She proceeded to spell out R.A.B.H.Y.A. – and then repeat: "Rabhya." I've since looked it up, and it's one of the 50 most popular names for girls in India. Anyone in that country would recognize it instantly, just as I would recognize Mary, or Cheryl, or Margaret, or many more girls' names that are familiar to me within my own culture.

Rabhya was friendly, and a good conversationalist, with impeccable, accent-free English. She – a Canadian citizen – was brought to Canada by her parents when she was nine. She still speaks Hindi at home.

Being "at home"

When we are in our homes, patterns of dress, behaviour, and conversation are familiar. We have become used to them, knowing how to respond when things happen. Customs and rules are well-worn and well-known.

Outside our residences, there are also many ways in which we are unconsciously "at home." We expect to speak our language and be understood; we know what signs and traffic lights mean; in a shopping mall, the sign that says "50% off, today only!" does not need to be explained.

And, we are not so comfortably "at home" if all the signs around us are in languages that we don't understand. Every seasoned traveller knows this, but what if our own home and region has dozens of languages, and all sorts of customs? Wouldn't it be, every day in every way, like standing at that intersection, thinking you're supposed to stop, while others blithely cross with no regard for the red hand?

In a culture where everybody has the same language, rules, and customs, everything from business to entertainment to personal relationships goes smoothly. In a culture with all sorts of languages and conflicting customs, nothing can get done smoothly. Accidents and messes will be common.

The Bible story of the Tower of Babel fits here. Genesis 11 says that people with a common language and culture were able to engage in an extraordinary project, and, when they lost their common language and culture, their project fell apart. A culture cannot function without a whole bunch of things held in common, and commonly understood.

Human cultures are a mix of language, written laws, and unwritten customs. And, as a culture begins to get established, it either forces the stranger to learn its ways, or it treats the stranger as unacceptable. Basically, it says, "Change and be like us, or go away!"

In many ways, Canada is a product of this process. Indigenous people were forced to conform to British culture, and there is the disquieting history of the mistreatment and/or exclusion of Jews, Chinese, Japanese, and other cultures. Yes, some Black slaves from the U.S. were able to escape to Canada, and the French were allowed to retain their language, but neither community fully integrated into the dominant culture of Canada. We only need look at the current "Bill 96" in Québec – a law promoting the use of French throughout the Province. People who speak French at home, want to be "at home" in business, education, recreation, and government. Increasingly, in Québec, no matter who you are, or what your culture, you must speak, work, and play in French, unless you're in your own residence. It is very much the phenomenon of "Change and be like us, or go away!"

Meanwhile, over the past 80 years, there has been a significant shift in this country towards a new social value: "inclusiveness." Refugees from around the world have been welcomed, and apologies for Japanese internment camps and Indian Residential Schools have become frequent and sincere. I can remember a time when the whole nation stopped to celebrate the birth of Jesus on December 25. Churches were packed, and all businesses were closed. Now there is a push to create official public holidays on the important days of many cultures, whether it be Eid, or Diwali, or Vaisakhi (a Sikh holiday), or Vesak (the Buddha's birthday), or Chinese New Year, and who knows how many other festive days there might be!

But "inclusiveness" has its limits. People of different cultures are definitely rejected if their values are not those of the proponents of inclusion. I once asked a member of a committee instituting "Equity, Diversity and Inclusion" (EDI) in their business, whether a "white supremacist" would be included in their organization. "No," was the reply, "not unless they change." I think that, if I had suggested including a member of the Taliban, or a "Freedom Convoy" trucker, I would have gotten the same reaction.

It amuses me that those who promote diversity and inclusion have something in common with those who want to retain and restore a European and colonial culture in their country! Both groups say, in effect, "Change, and be like us, or go away."

But my Christian faith has taught me to believe that, while all humans are different from one another, all are of equal value in the eyes of God. And, I must be respectful of others – even of other religions and cultures – for they are all children of God, and there may well be something that I can learn from them.

Meanwhile, for better or worse, I am "at home" in my Canadian, Christian-influenced culture. I will celebrate "Canada Day," even though my Indigenous friends remind me that when this country was created, their heritage was denigrated and suppressed. I will thank Indigenous people for accepting much of the inventions and technology that the settlers brought, and will also thank them for, in many cases, accepting Christianity, and becoming "at home" in the faith.

But I also know that no community can survive if all opinions, all practices, all languages, hold equal importance and weight. Some "values" and some behaviours are simply dead wrong, and even those that may be harmless, and just "different," cannot be held as being of equal weight. Either we're supposed to stop and wait at the red hand, or we are permitted to cross when no traffic is coming. Not both.

BURMESE

With her Majesty, Queen Elizabeth II celebrating her 70th anniversary on the throne, a lot has been said about the Ceremonial duties that have governed her life. The most significant role was the annual trooping of the colours which was a parade led by the Queen herself. For many years, she rode Burmese who was a gift from the RCMP. In a recent interview, she said that of all the horses she rode, Burmese was her favourite. Burmese was a calm docile mare who was undisturbed by all the noise that was inherent in riding through crowds that numbered in the thousands.

Burmese's comportment was in complete contrast to her sire Faux Pas who was in this writers opinion the nastiest horse to come out of the Ft. Walsh remount station in Alberta. In the summer of 1962, Faux Pas alongside a second stallion, Willie George were moved from the remount station to Depot Division where they both terrorized recruits who were sent in to groom them each morning. Both of these horses were only ridden by experienced instructors, but recruits were the "grunts" who had to groom them.

While Willie George was a cantankerous beast, Faux Pas gave new meaning to the word nasty. He routinely bit or kicked the person grooming him. To counter his biting, we had a special halter which included a wooden mouth piece that forced his mouth open. We were also instructed to tie this halter with a very short rope so that he had more trouble kicking. I don't know why, but it seemed that whenever our troop had morning stables, I was assigned Faux Pas for grooming. We quickly formed an understanding that I was the boss and he learned to stand still when I was in his box stall.

Recruits were not the only ones who suffered through problems with Faux Pas as he took any opportunity to make the instructors job more difficult. The most memorable instance of man against horse occurred one afternoon when our troop was scheduled for outdoor riding. The late Sgt. (Soon to be S/Sgt) Harry Armstrong brought Faux Pas out of the stables to give him an exercise ride. Harry was an accomplished rider and it was said that he could bring a horse to its knees by squeezing the horses girth. Faux Pas was being his usual independent self and so Harry decided to give Faux Pas the historic squeeze. It didn't work as Faux Pas just sidled over to the lamp post located nearby and unceremoniously rubbed him off.

Such a contrast; a gentle and cooperative mare, the offspring of such a mean horse.



It's about 3 km North on 334 and you'll see a Ukrainian flag on the Dunford's address sign to welcome you to the right place.

Good of the Association:


